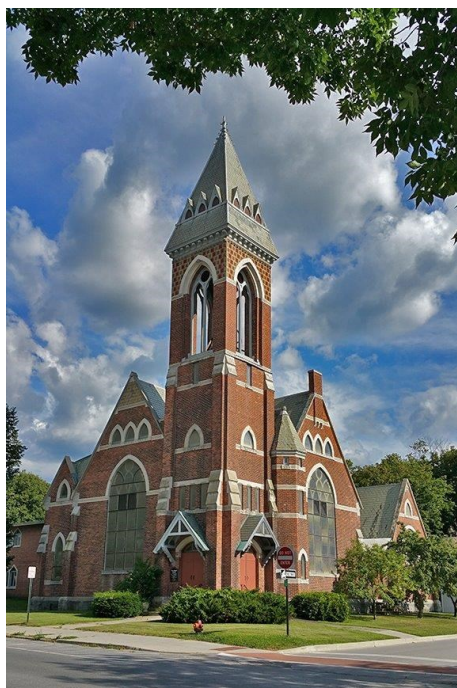

MINUTES OF THE 189TH ANNUAL MEETING JANUARY 21, 2018

The First Baptist Church held its 189th annual meeting on Sunday, January 21st, 2018. The meeting was brought to order at 11:00am by church clerk, Lisa Flynn.

The floor was open for someone from the congregation to step in as moderator for the meeting; as acting moderator Grace Becker-Wilson was not present. Cindy Butler made a motion to accept and Rhonda Harmon seconded the motion. All were in favor of Allyn Lindsey serving as moderator for the annual meeting.

Minutes: Allyn Lindsey served as moderator for the day's meeting and called for a motion to be made to accept the minutes from the 188th annual meeting. A motion was made by Byron Spafford to accept the minutes and Cindy Marsh Seconded the motion. All were in favor and motion was passed. A comment was made there was a typo in the table of contents; it should have said minutes of the 188th annual meeting.

There were no by-law changes made or proposed.

Budget: Byron spoke of the financial report. We are currently taking over 10% from the endowment to cover costs. This year will be a difficult year, if we are unable to continue to cost share the building's empty rooms. The trustees are working with a local non-profit organization to cost share the available rooms in the upcoming year. Cost sharing will generate money to continue maintaining church expenses. Cindy Marsh made a motion to accept the financial report and Sandy Williams seconded the motion. All were in favor and the motion was carried.

Nominations: The floor was opened for officers to continue on one year terms and to fill open positions on boards. Lisa Flynn will stay on as church clerk; Byron Spafford will stay on as church financial secretary. Grace Becker-Wilson had already agreed to accept the nomination to be church Moderator. Byron gave a detailed explanation of the job title for treasurer of trustees.

Rhonda Harmon and Cindy Butler will go on the Church Life Board and Sandy Williams will come off the Church Life board and join the cabinet as treasurer. Allyn Lindsey is also leaving the Church Life Board. A motion was made to accept the changes within the boards. Motion was made by Sandy Williams and seconded by Byron Spafford. A motion was suggested by Marion Riddle. The motion was presented to the congregation to "express gratitude and thanks to Wayne Kachmar; for his many years of unselfish gifts of time, expertise, leadership, and generous financial support to the benefit of all. He truly cared!" A motion was made by Cindy Marsh and seconded by Luella Root. Motion was carried.

Pastor's Report: Pastor Bob gave a brief talk about "The spirit at work among us. We are in a good place, and things will get worse before they get better." He is optimistic that things will get better. He closed in a prayer for the church and said grace before the potluck lunch.

Rhonda Harmon made a motion to adjourn the meeting and Byron Spafford second the motion. The meeting was adjourned at 11:27am.

REPORT OF THE BOARD OF TRUSTEES

The past year has been busy with a variety of changes within the building.

The trustee board continues to meet once a month to discuss church finances, building use, and cost sharing opportunities. The church continues to cost share with several non-profit businesses; Family Time (a division of PAVE), and VCIL Vermont Center for Independent Living. The Bennington Farmer’s Market operates out of Colgate Hall on the first and third Saturdays during the winter months and Help a Pet veterinary clinic operates on the second Sunday of each month throughout the year. The Hawthorn Recovery Center also continues to lease space in Colgate Hall. Colgate Hall currently has vacant office spaces available for occupancy. Cost sharing helps maintain the sustainability of the church.

The volatile stock market has put the state of the First Baptist Church’s finances in a state of uncertainty. The trustees and the cabinet will continue to meet with Dale Edwards in the upcoming year to discuss the budget and possible options for long term goals of the church.

On the recommendation of our financial advisor, a portion of the AssetMark funds was transferred to an annuity. This will allow it to continue to generate income but will have some protection for lost value when the market falls. The money transferred is that which is in trust and the income can be used only for its intended purpose. The income is available on a six year schedule.
